TAC Rule for required non-voting members: Title 31 Part 10 Chapter 357.4:

(g) Regional water planning groups shall add the following non-voting members of each regional water planning group:

- (1) staff member of the board (TWDB) to be designated by the executive administrator;
- (2) staff member of the Texas Parks and Wildlife Department designated by its executive director;
- (3) member designated by each adjacent regional water planning group to serve as a liaison;
- (4) one or more persons to represent those entities with headquarters located in another regional water planning area and which holds surface water rights authorizing a diversion of 1,000 acre-feet a year or more in the regional water planning area, and which supplies water under contract in the amount of 1,000 acre-feet a year or more to entities in the regional water planning area, or which receives water under contract in the amount of 1,000 acre-feet a year or more from the regional water planning area;
- (5) staff member of the Texas Department of Agriculture designated by its commissioner.

(i) Non-voting members of the regional water planning group shall receive meeting notifications and information in the same manner as voting members.
